

WIN the Ultimate Concert and Dining Experience at Elton John at a day on the green at Rochford Wines

Terms and Conditions

The Promoter is Swisse Wellness Pty Ltd (ABN 62 004 926 005) of 111 Cambridge Street, Collingwood VIC 3066 (**Promoter**).

The Promotion will commence at 12:00pm AEDT on 9 December and conclude at 12:00pm AEDT on 7 January 2020 (**Promotion Period**).

1. Entry in the Promotion is only open to Australian residents aged 18 years or older, excluding:
 - (a) management, employees, directors and contractors of the Promoter, its related entities and other agencies, firms or companies associated with the Promotion (including suppliers of the prize);
 - (b) a spouse, de-facto spouse, parent, guardian, child or sibling of a person referred to in paragraph (a) of these Conditions of Entry;
 - (c) persons who have breached the terms and conditions of any promotion run by or on behalf of the Promoter,

(Eligible Entrants). The persons referred to in paragraph (b) of these Conditions of Entry includes natural and non-natural relations (in the opinion of the Promoter) and the Promoter is responsible for determining whether a person is an Eligible Entrant in its absolute discretion.

2. Any entrant who, in the opinion of the Promoter,
 - (a) tampers or interferes with the entry or selection mechanism in any way;
 - (b) engages in any unlawful or improper conduct which jeopardises or is likely to jeopardise the fair or proper conduct of the Promotion; or
 - (c) who does not properly comply with the entry process; or
 - (d) engages in any unlawful or improper conduct during the fulfilment of the Prize, will be ineligible to win.

1. To enter and be eligible to win, Eligible Entrants must, during the Promotion Period, purchase two or more products on Swisse.com.au in one transaction (**Eligible Purchase**) AND complete and submit the online promotion entry form on swisse.com.au/competitions/celebrate-summer (**Online Entry Form**), including:
 - (a) first name, last name, email address, state and Swisse.com.au order number;
 - (b) by telling us in 25 words or less how you are going to celebrate summer; and
 - (c) by indicating their acceptance of these Conditions of Entry,**(Eligible Entry)**.
2. Each Eligible Entry will constitute one (1) entry into the draw.
3. Multiple entries are permitted, provided only one entry is permitted per Eligible Purchase.

1. Eligible Entrants must retain the order number for the Eligible Purchase which corresponds to each entry they submit in the promotion.
2. If requested by the Promoter, Eligible Entrants must produce, within the time requested by the Promoter at its absolute discretion, appropriate photo identification or other documentation required by the Promoter to verify their identity, age, eligibility to enter the Promotion and claim the prize (if won), and compliance with these Conditions of Entry.
3. If the items required by the Promoter are not received or an entrant has not been verified to the satisfaction of the Promoter within the period required by the Promoter, the entry(s) submitted by the entrant will be deemed invalid.
4. The prize will only be awarded following all validation and verification requirements of the Promoter being met to its satisfaction. In the event that the Eligible Entrant cannot provide suitable validation or verification, the Eligible Entrant will forfeit their right to a Prize and no substitute will be offered.

1. The competition will be judged at Swisse Wellness, 111 Cambridge Street, Collingwood VIC 3066, Australia (**Selection Location**) from all Eligible Entries received during the Promotion Period by a representative of the Promoter at 11am AEDT on 8 January 2020 (**Prize Selection**).

2. The Promoter may select additional reserve entries in the Prize Selection and record them in order to use in the instance an invalid entry or ineligible entrant is selected, in accordance with these Conditions of Entry.
3. The two winning Eligible Entries will be the answers that are judged to be the most creative AND supply a valid order number for an Eligible Purchase on Swisse.com.au. The two winning Eligible Entrants will each win: Four (4) x A-Reserve tickets to Elton John **a day on the green** at Rochford Wines (Victoria) on Friday 31 January 2020, including concert and dining package. Concert and dining inclusions: Car Parking pass (close proximity to venue), express show entry, three course meal in Rochford's Restaurant served alternating in air conditioned dining area, beverages - wine, beer and soft drink, private outdoor undercover patio, indoor bathroom facilities, Reserved Seating Area, a one-on-one session at the Swisse Wellness Bar and after show supper with tea and coffee.
